Self-Assessment Report on the Implementation of Principles, laid down in the C&C, at Varna Free University "Chernorizets Hrabar" (15th January 2012 – 31th March 2016)

Introduction

In January 2012 Varna Free University "Chernorizets Hrabar" was acknowledged "HR Excellence in Research" on the basis of published Internal Analysis¹ and Action Plan² for incorporating the *European Charter for Researchers* and the *Code of Conduct for the Recruitment of Researchers*.

A working group was created in order to prioritise, coordinate and deal with the 36 identified actions in the action-plan. The working group includes different stakeholders representing the Board of the University (Vice-rector on R&D), the academic staff (professors and researchers) and the administrative departments (Human Resources, Project Management, and Finance). It met in February 2013, February 2014 and June 2015 to assess the implementation of actions.

One year after acknowledgement (in February 2013) the implementation of the action plan was evaluated by a working group. On the basis of the evaluation the priority activities for the next one-year period were displayed. The report was endorsed by the Academic Counsel of the VFU (Protocol №4/19.02.2013).

A *Midterm Self-Assessment Report for the Implementation of the Action-plan*³ for obtaining the logo "HR Excellence in Research" was worked and endorsed by the Academic Counsel of the VFU at February 2014. The report has been submitted to the European Commission, General Direction "Research and Innovation".

An ongoing assessment of the results of action plan implementation and the readiness for external evaluation by the European Commission was endorsed by the Academic Counsel of the VFU (Protocol $N_{2}9/25.06.2015$).

The overall implementation of the action plan for the four years possession of HR-logo has been developed by a working group of VFU, led by prof. Pavel Pavlov, PhD – Vice-Rector in R&I, and endorsed by the University Counsel in Research on 6th of April 2016.

The self-assessment report presents the efforts made by Varna Free University "Chernorizets Hrabar" in the context of the HRS4R for the improvement of:

- (1) the ethical and professional aspects in research;
- (2) the recruitment of researchers;
- (3) the working conditions and
- (4) the career development through training.

All these four principles are laid down in the *European Charter for Researchers* and the *Code* of Conduct for the Recruitment of Researchers.

The results are represented with the using of the action plan's structured tables (see *Annex I*). This allows not only the follow-up of the implementation of each action, but also:

- the laid down aims, the evolution of what is achieved and what still has to be done;
- the link between the action and the context of the common implementation of dimensions;
- the dissemination of results, etc.

This type of presentation could demonstrate the level of achievement of the action plan, the existing evidences, etc.

According to the analysis the following main conclusions could be made:

- all 11 planned actions in *dimension I* "Ethical and Professional Aspects" are implemented. It should be emphasized, that the Ethical Code for Research at VFU, created by a VFU team, is used as the basis for the development of the National Ethic Code of Conduct for Carrying out Research. The last one is still preparing by the Ministry of Education and Science.
- It is implemented all 5 actions in *dimension II "Recruitment"*. The VFU's accession to the European network EURAXESS in 2014 is a part of implementation of this dimension as well. VFU hosted the *Euraxess Road Show 2015*⁴ on the 29th of October 2015. The attraction and recruitment of foreign researchers is still outlining as a major difficulty. The team of VFU has experience in work in international research groups, but till now there is no one recruited researcher. It is recognized as a weakness the lack of direct links from the VFU web site to the EURAXESS site and the web-sites of other scientific networks, universities and institutes as well. It is still forthcoming the hard work on this dimension with the using of the experience, gained during the years.
- There are 13 actions, mentioned in the action plan in *dimension III "Working Conditions"*. Ten of them have been adopted. The other three of them were not in priority in the self-assessment period. The reason is there are not recruited foreign researchers at VFU. The main efforts were focused on creation of internal university legislation for ethics and monitoring mechanisms of its application, and on develop of measures for protection of intellectual property. It was very

important to promote them among VFU academics. The developing of monitoring system is laid down in the new action plan 2016-2020.

- All five planned actions in *dimension IV "Training*" are implemented. It has to be noted that more than 120 persons from the university academic staff passed training courses to improve the skills for conducting of research, methodology of research, specialized English language, and digital competences. The implementation of this dimension was the reason to select and include VFU in the programme of the mutual learning seminar 'Sharing experience to better implement the Human Resources Strategy for Researchers (HRS4R)', organized by European Commission, GD "Research&Innovation" and held on 9th of October 2014 in Brussels, Belgium.

All planned actions are implemented step-by-step and introduced on the required university levels. The aim of the university management is the implementation of all principles, laid down in the *European Charter for Researchers* and the *Code of Conduct for the Recruitment of Researchers*, because the HR logo is an important sign for the VFU which certifies the system of maintaining the European quality for education and research.

As a conclusion, it could be summarized that:

- 33 from 36 planned activities in the action plan have been implemented in the period of self-assessment. Only 3 actions were identified as non-priority for the period and are included in the actualized action plan 2016-2020.
- As a result of the implementation of *dimension IV "Training"*, VFU was selected to present its experience and good practice on the mutual learning seminar 'Sharing experience to better implement the Human Resources Strategy for Researchers (HRS4R)', organized by European Commission, GD "Research&Innovation" (9th of October 2014, Brussels, Belgium);
- VFU promote HR-logo on national level by participation in EURAXESS Roadshow 2014, which took place in Plovdiv University "Paisii Hilendarski" and in Sofia University "St. Kliment Ohridski", and in EURAXESS Roadshow 2015, which was held at VFU;
- Ethical Code for Research at VFU was used as a good practice for the National Ethic Code of Conduct for Carrying out Research, developed by the Ministry of Education and Science;
- It is established an environment at VFU, which increases motivation of researchers and academic staff to participate in international scientific projects, to develop research career and to realize motilities.

The self-assessment report was written by a team consisting of Prof. Pavel Pavlov, PhD – Vice-Rector in Research and the team leader, Assoc. Prof. Rositsa Petkova-Slipets, Ph D – HR Logo Contact Person, Scientific Secretary of the Faculty of Architecture and Researcher, and Assoc.
