12. Course contents: Criminal Law – general part is a basic forensic science. Its subject is the substantive criminal law as part of the active objective law. The course includes basic principles, concepts, categories and institutions of modern criminal law. The aim of the course within the frames of the Master's degree program Forensic Expertise is the students to obtain profound knowledge about the categories, institutes and the special concepts of criminal law. Having knowledge of these concepts is extremely important for students' future practical work.
